You create an application by using the Microsoft .NET Framework 3.5 and Microsoft ADO.NET. The application connects to a Microsoft SQL Server 2005 database.

You write the following code fragment to generate a storage schema definition for a stored procedure from the database.

The application uses two namespaces named ContosoModel.Store and ContosoMode1.

The ContosoModel.Store namespace contains the storage schema. The ContosoMode1 namespace contains the conceptual schema that has an entity named Supplier.

You need to create a function named GetSuppliersInCountry that returns a list of Supplier entity instances.

What should you do?

Explanation: This simple statement returns a collection of strings. It is the default behavior for SELECT statements.

Note:For example, if customers is a collection of type Customer that has a property Name that is of type string, selecting Name from customers will yield a collection of strings, as illustrated in the following example.

SELECT customers.Name FROM customers AS c
```

Explanation: Call **Attach** on the ObjectContext to attach the object to the object context. Do this when the object already exists in the data source but is currently not attached to the context.

TheObjectContext.SaveChangesmethodpersists all updates to the data source and resets change tracking in the object context.

Incorrect answer:

A, C: there should be no input parameter true:

context.SaveChanges(true);

D: No such methodAddToCustomer.

QUESTION NO: 6

You write the following code segment. (Line numbers are included for reference only.)

Explanation: We use ROW(1) to get the row with the ID Value of 1.
We then create a reference to the object with CREATEREF.
Finally we use DEREF to get the specific row.

Note:

CREATEREF fabricates references to an entity in an entityset.

Syntax:

CreateRef(entityset_identifier, row_typed_expression)

Arguments:

entityset_identifier

The entityset identifier, not a string literal.

row_typed_expression

A row-typed expression that corresponds to the key properties of the entity type.

Note: KEY: Extracts the key of a reference or of an entity expression.

KEY(createref_expression)
