#### Question No: 11 DRAG DROP - (Topic 0)

Click the Task button. You want to monitor the number of licenses being used on your network for Microsoft Office XP Professional. Place the steps in the correct order to accomplish this task.

- Position the tip of the mouse cursor over the object you want to move (usually a panel, picture, or words).
- 2. Click and hold down the left mouse button.
- 3. Move the mouse (without releasing the mouse button) to move or "drag" the object.
- 4. Position the object so that its upper left corner is over the place you want it to go.
- 5. Release the mouse button to place or "drop" the object into its new location.

Hint: You can tell where to drop objects by watching the mouse cursor.

- Remember that the mouse's "hot spot" is the very tip of the cursor arrow. So, when dragging, place the tip of the mouse cursor arrow over the place you want to drop the object, even if the object itself is not lined up with its target.
- The mouse cursor changes shape as you drag objects around the screen. The cursor shape indicates where you can drop objects. See the table below.
